# The Libya (Restrictive Measures) (Overseas Territories) (Amendment) Order 2012

It is notified for public information that the Libya (Restrictive Measures) (Overseas Territories) (Amendment) Order 2012 has been extended to St Helena, Ascension and Tristan da Cunha with effect from 17 February 2012.

The Order amends the Libya (Restrictive Measures) (Overseas Territories) Order 2011 (as amended previously by the Libya (Restrictive Measures) (Overseas Territories) (Amendment) Order 2011) to give effect to a decision of the UN Sanctions Committee of 16<sup>th</sup> December 2011 to remove the Central Bank of Libya and the Libyan Arab Foreign Bank from the scope of the partial asset freeze imposed in UNSCR 2009 (2011), and to reflect Council Regulation (EU) No 1360/2011 adopted by the Council of the European Union on 20<sup>th</sup> December 2011 giving effect to that decision in the EU.

## The Sudan and South Sudan (Restrictive Measures) (Overseas Territories) Order 2012

It is notified for public information that the Sudan and South Sudan (Restrictive Measures) (Overseas Territories) Order 2012 has been extended to St Helena, Ascension and Tristan da Cunha with effect from 14 March 2012.

The Order gives effect in the specified overseas territories to measures adopted by the European Union in Council Decision 2011/423/CFSP adopted on 18 July 2011 and implemented in Council Regulation 131/2004 as amended, including by amendments introduced following adoption of Council Regulation 1215/2011 on 24 November 2011. Council Decision 2011/ 423/CFSP repealed Common Position 2005/411/CFSP and extended some restrictive measures to South Sudan which became a separate and independent State on 9 July 2011.

# The International Criminal Tribunal for the former Yugoslavia (Restrictive Measures) (Overseas Territories) (Revocation) Order 2011

It is notified for public information that the International Criminal Tribunal for the former Yugoslavia (Restrictive Measures) (Overseas Territories) (Revocation) Order 2011 has been extended to St Helena, Ascension and Tristan da Cunha with effect from 18 January 2012.

This Order revokes the International Criminal Tribunal for the former Yugoslavia (Restrictive Measures) (Overseas Territories) Order 2004 made to give effect, in the overseas territories to which the 2004 Order extended, to Council Common Position 2004/694/CFSP (as extended by Common Position 2009/717/CFSP) which was adopted by the Council of the European Union on 11<sup>th</sup> October 2004 to provide for certain restrictive measures with the aim of freezing all funds and economic resources belonging to persons who had been indicted by the International Criminal Tribunal for the former Yugoslavia for war crimes but were still at large. Council Decision 2010/603/CFSP, adopted on 7<sup>th</sup> October 2010, extended the restrictive measures until 10<sup>th</sup> October 2011. The restrictive measures provided for by Council Decision 2010/603/CFSP were not further extended and expired on 10<sup>th</sup> October 2011.
