The Tunisia (Restrictive Measures) (Overseas Territories) Order 2011

It is notified for public information that the Tunisia (Restrictive Measures) (Overseas Territories) Order 2011, has been extended to St Helena, Ascension and Tristan da Cunha with effect from 18 March 2011.

The Order places restrictive measures on certain persons, entities and bodies responsible for the misappropriation of Tunisian State funds, and persons associated with them who are thereby depriving the Tunisian people of the benefits of sustainable development of their economy and society and undermining the development of democracy in the country.

No.92.**The Terrorist Asset-Freezing etc. Act 2010 (Overseas Territories) Order 2011**

It is notified for public information that the Terrorist Asset-Freezing etc. Act 2010 (Overseas Territories) Order 2011, has been extended to St Helena, Ascension and Tristan da Cunha with effect from 31 March 2011.

The Order replaces the existing power that the Territories have to freeze the assets of those suspected of being involved in terrorism under the Terrorism (United Nations Measures) (Overseas Territories) Order 2001, which is vulnerable to be quashed in the Supreme Court. Applying Part 1 of the 2010 Act to the Territories will give them similar power to the Treasury's powers under the Terrorist Asset Freezing etc. Act 2010, allowing them to make asset freezes, licence exemptions, and to require and share information within their own territories.
