**The Iran (Restrictive Measures) (Overseas Territories) (Amendment) Order 2012**

This Order gives effect to the amendments to the 2011 Regulation adopted by the Council of the European Union in Council Decision 2012/168 (CFSP) of 23<sup>rd</sup> March 2012 and implemented in Council Regulation (EU) No. 264/2012 (“the 2012 Regulation”) of 23<sup>rd</sup> March 2012. The amendments incorporate into the 2011 Regulation a prohibition on the sale, supply, transfer or export to Iran of equipment which may be used for internal repression. The amendments also introduce additional restrictive measures, namely a prohibition on the sale, supply, transfer or export of telecommunications monitoring equipment, technology or software to any person in Iran or for use in Iran and related prohibitions on technical assistance, brokering services, financing and financial assistance.
