Wednesday, 18 December 2013 - Monday, 23 December 2013

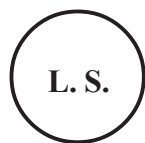

APPOINTMENT OF JUSTICE OF THE PEACE FOR ASCENSION ISLAND

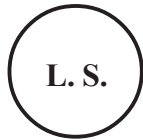
