Instrument, appointing JUDITH MARY LEON, to be Governor's Deputy.

WHEREAS it is provided inter alia, in Section 28 of the Constitution set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009 that whenever the Governor has occasion to be absent from the seat of government for a period that he or she has reason to believe will be of short duration, she may, by Instrument under the public seal, appoint any person in St Helena to be her Deputy during such absence and in that capacity to discharge on her behalf during such absence such of the functions of the office of Governor as may be specified in that Instrument:

AND WHEREAS I shall be on annual leave from 17 December 2016 to 5 January 2017.

Now therefore, I Lisa Phillips, Governor of St Helena do hereby appoint Judith Mary Leon, Head of Governor's Office to be my Deputy during the period of my absence from 17 December 2015 to 5 January 2017 inclusive and in that capacity to discharge on my behalf all such powers and authorities vested in the Governor (save the power of pardon) as, but no more than, she may from time to time deem to be necessary for the peace, order and good Government of St Helena, Ascension and Tristan Da Cuhna and the well being of its people.

And I charge the said Judith Mary Leon that she shall, during my aforesaid absence, conform to and observe all such instructions as I may from time to time address to her for her guidance.
