FORESTRY ORDINANCE, CAP. 92

VARIATION OF NATIONAL FORESTS

- 1. Notice is hereby given pursuant to the provisions of section 12 of the Forestry Ordinance, Cap. 92, that the Governor in Council is proposing to vary the Forests constituted by Statutory Rules and Orders as set out in the first column of the Schedule, so that land as described in the Schedule may be excised from the relevant National Forests and made available to the Crown Estates Officer to be used for other purposes for the reasons set out in the last column.
- 2. Any person having any objections to the proposed variation of the said Constitution Orders or wishing to make any representations in connection therewith, should submit such objection or representation, in writing, to the Chief Secretary, The Castle, Jamestown on or before 20 May 2014.
 - 3. According to this proposal variation shall not come into force before 1 July 2014.
- 4. A copy of the Map will be made available in Essex House from the Estates Management Office and a plan of the areas concerned may be inspected at the Offices of the Agriculture and Natural Resources Division, Scotland, St Paul's.
