21.3 ADMISSION POLICY

The proposed School Admission Policy report was circulated prior to the meeting.

The Committee endorsed the staged approach for children to attend Nursery once they had reached the age of three years.

The Committee agreed that the catchment areas will be as follows:

St. Paul's Primary -

All homes in the St. Paul's, Sandy Bay and Blue Hill districts

HTH - All homes south of Lantana Road stopping west at the residence of Mr Cyril Joshua and all homes south of Wireless Station Road, stopping at the HTH boundaries on the west, east and south.

All homes in areas south west of Gordon's Post and on Gordon's Post Road.

Pilling Primary –

All homes in Rupert's Valley, the Briars and in Jamestown.

HTH - All homes north of Lantana Road stopping west at the residence of Mr Cyril Joshua and all homes north of Wireless Station Road stopping at the HTH boundaries on the east and west.

All homes north of Christening Bank stopping at Prospect House Junction and Gordon's Post (therefore not including those on Gordon's Post Road).

Harford Primary -

All homes east of St. Paul's boundary and Jamestown boundary including all of Longwood, Levelwood and Deadwood areas.

All homes south of Christening Bank and east of Prospect Junction thereof will be for children attending Harford Primary School.

The Committee endorsed the School Admission Policy which will be an internal policy subject to minor amendments prior to implementation.
