WHEREAS it is provided inter alia, in Section 28 of the Constitution set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009 that whenever the Governor has occasion to visit Ascension or Tristan da Cunha, the Governor may, by Instrument under the public seal, appoint any person in St Helena to be her Deputy during such absence and in that capacity to discharge on her behalf during such absence such of the functions of the office of Governor as may be specified in that Instrument:

**AND WHEREAS** I shall be absent from St Helena for official business on Ascension Island from 10 May 2017 – 16 May 2017.
