### PASSPORT (FEES) ORDINANCE

AN ORDINANCE TO IMPOSE FEES FOR THE ISSUE OF PASSPORTS.

#### Commencement

[16 November 1979]

#### Short title

1. This Ordinance may be cited as the Passport (Fees) Ordinance.

### **Interpretation**

- **2.** In this Ordinance—
- **"Immigration Officer"** means the Chief of Police or such officer as may be appointed by the Governor:
- "Passport" includes British passport, alien passport and emergency passport.

#### **Fees**

**3.** The fees set out in the Schedule are payable to the Immigration Officer in respect of the matters to which they relate.

## Schedule may be amended

**4.** The Governor in Council may from time to time by Order add to, alter, vary or replace the fees set out in the Schedule.
