NOTES:

1. It is unlawful for any person to enter or remain in St. Helena unless he or she holds a valid short term or long term entry permit or is exempt from entry permit requirement. Exempt persons are;
 - (a) A person who has St. Helenian status or is the dependant of a person who has such status;
 - (b) A person and their dependant(s) in the service of the Crown or who is present in fulfilment of the provisions of a contract entered into on behalf of Her Majesty (whether in right of Her Government of the United Kingdom or in right of Her Government of St. Helena) whereby goods or services are provided to Her Government of St. Helena;
 - (c) A person who, upon arrival in St. Helena is an officer or a member of the crew of a vessel which has been approved by the Chief Immigration Officer for the purposes of this subsection and who is under an engagement requiring him to leave on that vessel;
 - (d) Any consular officer within the meaning of the Vienna Convention on Consular Relations 1963;
 - (e) A person who arrives on a vessel, the Master of which has been granted a landing permission authorising a specified number of passengers and crew of that vessel to enter St. Helena without obtaining an entry permit and that person is within that specified number;
2. Separate restrictions apply as to employment and land ownership by immigrants
3. It is a criminal offence to give false information.
