Team Manager Adult Community Team (Grade E).

The Team Manager (Adults and Community) will be a key member of the Directorate's Leadership team and will be responsible for social work practice around work with vulnerable Adults and people living in the community with disability or other vulnerabilities which impact their wellbeing and safety.

This is an exciting opportunity for someone who wants to progress their career working alongside the current TC manager.

The post holder will work for 8-10months alongside the current TC) Team Manager. This will be an opportunity to learn and develop core leadership and technical skills and knowledge in order to take the role forward in a substantive manner.

The purpose of the designate role is to offer a supportive and learning opportunity to the relevant individual so they feel empowered and prepared to take the service forward in a full management capacity within the next 8- 10 months.

Clinical Lead for Residential and Community Services (Grade E).

The Clinical Lead works in collaboration with the community nursing team, Physiotherapy service, Occupational therapy, hospital services, frontline team members across the residential services, other internal and external partners, as well as residents and families, to ensure that quality resident-centred care is designed, delivered, measured and improved. The Clinical Lead ensures application of best clinical practices at the point of care, with the goal of greater coordination of services across health, community, social and justice sectors so that every resident with health issues receives timely and quality care matched to their need.

This is a vital role with the directorate to ensure the service is able to provide excellent residential and community care for adults within the St Helena community.

The successful candidate will have the opportunity to work alongside the current TC practitioner who currently occupies this role.
