## CHRONOLOGICAL TABLE OF ORDINANCES TO 1 NOVEMBER 2017

- This Table shows the current status of all extant Tristan da Cunha Ordinances enacted between 1923 and November 2017. It also shows the destination of all Ordinances enacted since 1967 when the first separate Revised Edition of the laws of Tristan da Cunha was published.
- The table includes St Helena Ordinances enacted for Tristan da Cunha up to 1 September 2009 when the Constitution changed.
- Ordinances repealed, disallowed or otherwise dealt with prior to 1926 are omitted; details can be found in the 1929 Revised Edition of the Laws of St Helena, Ascension and Tristan da Cunha. Laws are also shown as 'Omitted' if they are spent or have had effect or are purely personal; see the separate <u>List of Omitted Ordinances</u>.
- A reference to an Ordinance being 'listed' is to the Alphabetical List of Ordinances or to the List of Ordinances by Category elsewhere on this website. The revised texts of all those Ordinances are in this Revised Edition and there are links in the Alphabetical List.
- A reference to a 'Cap.' is to a Chapter in the 2001 Revised Edition of the Laws.
- The Table does not include subsidiary legislation, texts of which can be found under the respective enabling Ordinance.
