Welfare of Children (Amendment) Regulations 2018

ADVICE SOUGHT

1. Council are asked to consider and recommend for enactment the Welfare of Children (Amendment) Regulations 2018 attached at Annex A.

BACKGROUND & CONSIDERATIONS

- 2. The Welfare of Children (Amendment) Regulations 2018 amend regulations made under section 166 of the Welfare of Children Ordinance 2008. Section 166 gives the Governor in Council general powers to make regulations for carrying the Ordinance into effect.
- 3. Currently, one of the Elected Members of the Legislative Council is appointed to the role of Children's Champion. There is no statutory basis for that appointment.
- 4. The person appointed Children's Champion is a member of the Safeguarding Children Board and has a role pursuant to r.19 of the Welfare of Children (Children's Residential Home) Regulations in scrutinizing the action of the Safeguarding Directorate when restrictions are placed by the communications to or by a child who is living in the children's home.
- 5. These regulations provide a statutory basis for the appointment of the Children's Champion and ensure that there is always someone fulfilling that role. The role of the Children's Champion is covered in Annex B.
- 6. There is also an amendment to ensure that the Safeguarding Children Board should always have nominees from children's social services and from the Health department as members.

11. The SCDC first considered the Regulations on 10.01.18 and recommended them for consideration by ExCo as soon as possible. Following consultation with the Safeguarding Children Board, the Regulations were again considered by SCDC on 11.04.18 and approved with minor amendments.

12. Positive or no public reaction is anticipated.

13. The decision should be included in the ExCo Report and associated broadcast.
