There was also a section 11 correction notice for the Law Revision to include certain 2017 amendments that were omitted from the Law Revision, but we held back that notice to avoid any confusion (i.e. we didn't want to publish that notice immediately after an announcement that the changes to the Aerodrome Regs were being deferred)

Shipping Registry:	Being drafted		These aren't strictly Regulations as such, but there was a Policy document to be published to change the criteria for the registration of fishing vessels, yachts and pleasure vessels in SH Legislative Drafter sent the revised policy statement through sometime in June but I haven't had any further feedback from Nicole Shamier or Andrew Radley.
