# ST HELENA NATIONAL TRUST ORDINANCE, 2001

### ST HELENA NATIONAL TRUST (AMENDMENT) REGULATIONS, 2019

In exercise of the powers conferred by section 14 of the St Helena National Trust Ordinance, 2001, the Governor in Council makes the following Regulations:

#### **Citation and commencement**

**1.** These Regulations may be cited as the St Helena National Trust (Amendment) Regulations, 2019, and come into force on ....

### Trust Council

**2**. The following regulation is inserted in the St Helena National Trust Regulations, 2002, after regulation 4:

# "Establishment of Council

4A. (1) The Council is to consist of the following members—

- (a) the president, vice-president, secretary, treasurer and 2 at-large members, who are to be elected at the annual general meeting for a term referred to in regulation 5;
- (b) 2 members appointed by the Governor in Council from persons who are members of the Trust;
- (c) the Chair or designated representative of each of the bodies set out in sub-regulation (2);
- (d) any other persons the Council co-opts as members.

(2) The following bodies are each entitled to appoint one member of the Council—

- The St Helena Heritage Society;
- The St Helena Nature Conservation Group;
- The St Helena Tourism Association;
- The St Helena Diving Club;
- The St Helena Art and Crafts Association;
- The St Helena Farmers' Association.

(3) The Council is to be deemed fully constituted and all acts and proceedings of the Council are to be deemed valid in all respects if and so long as 6 members have been appointed or elected to the Council and is not to be deemed invalid by reason of a vacancy in its membership or by reason of a defect in the appointment or election of a member to it.

(4) If any elected member of the Council dies or resigns, the Council may appoint in his or her place another member of the Trust to be a member of the Council and any member so appointed continues in office until the next annual general meeting after his or her appointment.

(5) Only members specified in section 9(1)(a), (b) and (d) of the Ordinance qualify for election or appointment to the Council.

(6) The president must fix the date, time and place of meetings of the Council—

- (*a*) as often as he or she considers it necessary, but in any case at least once in a period of 6 calendar months; and
- (b) at the written request of a majority of the Council made at least 14 days before the date proposed by such members for a meeting.

(7) Subject to these regulations, the Council may regulate the proceedings of its meetings as it thinks fit.".

### **Election of Officers and members**

**3.** The heading of regulation 5 is revoked and the following is substituted:

### "Election of officers and members of Council".
