

Statistical Update COVID-19 country risk classification

Published on 9 September 2020

This is a regular weekly update to the classification of countries based on their current 14-day COVID-19 reported cumulative case prevalence rate published by the European Centre for Disease Prevention and Control (ECDC), and the latest quarantine status issued by the UK Government.

- GOLD: No reported cases in last 14 days and exempt from UK quarantine
- GREEN: 14-day reported cumulative case prevalence higher than zero but less than the medium threshold (0.04%) and exempt from UK quarantine
- AMBER: 14-day reported cumulative case prevalence above the medium threshold (0.04%) but less than the high threshold (0.10%) or countries who are below the medium threshold but not exempt from UK guarantine
- RED: All countries with 14-day reported cumulative case prevalence above the high threshold (0.10%)

Not Countries not exempt from UK quarantine but with no reported cases, and countries classified: whose data are not reported by ECDC

** Two new cases have been reported on Ascension Island on 4/9/2020; since these are in quarantine, the 14-day case prevalence rate in the Ascension population is reported as zero and the classification remains Gold.
