## **Memorandum for Executive Council**

#### **SUBJECT**

### **PUBLIC HEALTH (AMENDMENT) BILL 2020**

Memorandum by the Chairman of the Public Health Committee

#### ADVICE SOUGHT

1) Council is asked to consider and advise whether the Public Health (Amendment) Bill, 2020, should be printed, published and presented as Government Business at the next formal meeting of the Legislative Council. A copy of the Bill is at Annex A.

## BACKGROUND & CONSIDERATIONS

- 2) The Public Health (Prevention of Formidable Diseases) (Coronvirus) Regulations ("Coronavirus Regulations") were enacted on 3 April 2020.
- 3) The Coronavirus Regulations created a number of criminal offences. Some of those offences have punishments of up to 12 and 18 months imprisonment. The level of punishment for these offences was requested by all Elected Members (not just ExCo Members).
- 4) Pursuant to the Interpretation Ordinance 1968, unless specified in the enabling Ordinance, the maximum sentences of imprisonment allowed in any Regulation is 6 months. Therefore, at present although the Coronavirus Regulations state a maximum sentence of imprisonment of up to 18 months the maximum that can be imposed is actually only 6 months.
- 5) The Public Health Amendment Bill, 2020, inserts an enabling provision into the Principal Ordinance which allows for periods of imprisonment up to 18 months in subsidiary Regulations.
- 6) As the Coronavirus Regulations are made under the Public Health Ordinance this means that for contravention of relevant offences sentences of imprisonment up to 12 or 18 months can now be imposed.
