TRADE MARKS (REGISTRATION) ORDINANCE, 1949

TRADE MARKS (REGISTRATION)(AMENDMENT) RULES, 2020

In exercise of the powers conferred by section 13 of the Trade Marks (Registration) Ordinance, 1949, the Governor in Council makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Trade Marks (Registration)(Amendment) Rules, 2020, and come into force on 1 July 2020.

Fees

2. The First Schedule to the Trade Marks (Registration) Rules, 1949, is amended by revoking the table of fees and substituting the following:

On an application under section 16 of the Ordinance:
