Firearms (Amendment) Bill, 2020

Memorandum by the Chairman, Social and Community Development Committee

ADVICE SOUGHT 1. Council is asked to advise whether the attached Firearms (Amendment) Bill, 2020 (Annex A) should be printed and published and tabled as Government business at a forthcoming formal meeting of the Legislative Council.

BACKGROUND & 2. Earlier this year, it was suggested by the Director of Police that the Museum of Saint Helena should seek an amendment to the Firearms Ordinance, 1997, to provide for a licence for the Museum, thus obviating the need for those responsible for the Museum's management to have Firearms or Shot Gun certificates, which would be in line with arrangements in the UK.

3. In the United Kingdom, the Firearms (Amendment) Act 1988 provided for a licence to be granted to Museums which wish to exhibit firearms; as such those employed in the Museum are not required to hold a Firearm Certificate. It follows, therefore, that consideration should be given to those responsible for the management of the Museum of Saint Helena to be exempt also from the requirement to hold a Firearm Certificate for each of the firearms in their collection.

4. The Museum of Saint Helena has a small collection of firearms of historical cultural value. The Island has a long history of being a fortified outpost of the East India Company and the British Empire. Many of the firearms held by the Museum of Saint Helena were in use by those stationed here as well as local militias. In addition, the Island also has a more recent history of excelling in marksmanship, locally and internationally. Museum staff can better promote this history at the Museum with display and information of such firearms in original condition. The Museum does not have any ammunition for these firearms, as most of them are so old that it would not be possible to obtain such.

5. The attached Firearms (Amendment) Bill, 2020 amends the 1997 Ordinance to make provision for the granting of a Firearms Certificate to the Museum of Saint Helena for purposes of holding and exhibiting firearms and ammunition of historical interest.

Persons responsible for the management of the Museum and its employees may possess, purchase or acquire such firearms, ammunition or prohibited weapons for purposes of the Museum without being required to hold an individual Firearms Certificate. The Bill also excludes from the application of the Ordinance all muzzle loading cannons on St Helena which were manufactured before 1900.

FINANCIAL 6. There are no financial implications associated with the publication of the Bill or its implementation if enacted by Legislative Council in due course.
