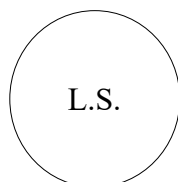

**AN ORDINANCE**

**to provide for the services of the financial year**  
**1<sup>st</sup> April 2026 to 31<sup>st</sup> March 2027**

Enacted by the Governor of St. Helena with the advice and consent of the Legislative Council of St. Helena.

**Short title**

1. This Ordinance may be cited as the Appropriation Ordinance, 2026.

**Consolidated Fund—provision for the financial year 2026/2027**

2. The Governor may cause to be issued out of the Consolidated Fund and applied to the services of the financial year commencing on 1<sup>st</sup> April 2026, a sum not exceeding forty nine million, one hundred and seventy two thousand pounds, which is appropriated for the purposes and services described in Schedule I and II, to this Ordinance.
