CONSTITUTION OF ST HELENA, ASCENSION AND TRISTAN DA CUNHA

Appointment of Acting Judge

WHEREAS Part 6 of the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order, 2009 establishes a Supreme Court for St Helena, and section 84(1) thereof provides for the appointment of a Chief Justice and such number of other judges of the said Court as may be prescribed by law.

AND WHEREAS it is provided in section 84(3)(b) of the Constitution that if the state of the business of the Supreme Court makes it desirable that an additional person should be appointed by whom the Supreme Court may be held, the Governor, acting in his or her discretion, may decide that an acting judge should be appointed to hold the Supreme Court.

AND WHEREAS it is provided in sections 90(2) and 91(3)(a) thereof that the Governor, acting in accordance with the recommendation of the Chief Justice, may appoint an acting judge of the Supreme Court for a term specified in the instrument of appointment.

AND WHEREAS the Chief Justice Charles Ekins has recommended the appointment of Mr Duncan Matthew Cooke as acting Judge of the Supreme Court of St Helena for the purpose of holding the case management hearings of the criminal cases committed to the Supreme Court for trial as authorised by the Chief Justice.

NOW THEREFORE, in exercise of the powers vested in me by section 90(2) and 91(3)(a) of the Constitution, and acting in accordance with the recommendation of the Chief Justice, I hereby appoint Mr Duncan Matthew Cooke as an acting Judge of the Supreme Court for the above purpose and for all matters as delegated by the Chief Justice for a period of three years with immediate effect.
