BIRTHS AND DEATHS (REGISTRATION) (FORMS AND FEES) REGULATIONS, 2020

In exercise of the powers conferred by section 22 of the Births and Deaths (Registration) Ordinance, 2020, the Governor makes the following Regulations:

Citation

1. These Regulations may be cited as the Births and Deaths (Registration) (Forms and Fees) Regulations, 2020.

Forms

2. The forms in Schedule 1 are to be used in respect of the matters as set out therein.

3. The fees in Schedule 2 are payable in respect of the matters set out therein.
