#### 2. The Hon Gavin Ellick to ask the Hon Chief Secretary:

Will the Honourable Chief Secretary tell this Council what is the policy and/or practice of SHG in regard to the length of contracts for senior officials in local employment of SHG?

## 3. The Hon Christine Scipio to ask the Hon Chairman of the Public Health Committee:

Will the Honourable Chairman of Public Health Committee tell this House what facilities are available for the hospitalisation of children at the General Hospital?

#### 4. The Hon Cyril Leo to ask the Hon Chief Secretary:

Will the Honourable Chief Secretary tell this Honourable House if the St Helena Government received a request from Howard University in Washington DC USA to allow research to be conducted on the human skeletal remains of the Liberated Africans in order to reconstruct a snapshot of the lives of the mid-19th century individuals originally buried at St Helena?

Will the Honourable Financial Secretary tell this Council what is the current situation regarding the carrying of air freight from St Helena on the Titan charter flights?

Will the Honourable Chairman of Public Health Committee tell this Council will the results of Covid 19 testing conducted on St Helena be made public?

Will the Honourable Chief Secretary tell this Council, if the new immigration policy is approved, if it is intended by SHG for those who would have permanent residence to be able to work on Technical Contracts of Assistance?

## 8. The Hon Cyril Leo to ask the Hon Chairman of the Public Health Committee:

Will the Honourable Chairman of the Public Health Committee tell this Honourable House if the expert local medical advice to elected representatives is quarantining at Bradley's should stop and self-isolating throughout the community is strongly recommended for all new arrivals?

Will the Honourable Financial Secretary tell this Council how it is envisaged that financial assistance will be provided to the private sector following the closure of Enterprise St Helena on 31<sup>st</sup> March 2021?
