## Introduction



Notable achievement against targets was made in the following areas for the fourth quarter:

#### **EDUCATION**

- 100% 4 of the 4 teacher trainees in Year 2 and 3 have achieved the relevant qualification.
- ❖ St Helena Community College has met 64.93% of training needs identified.
- ❖ 100% of students supported financially whilst on the Scholarship Scheme a new cohort of 3 students left St Helena for UK studies in September. We now have 8 students on scholarship.
- 93.47% of staff retained from school Year 2018-19 to School Year 2019-20 to date.

#### **ENVIRONMENT NATURAL RESOURCES & PLANNING**

- 90% implementation of 4 Producer Development Plans.
- ❖ 5% reduction of recyclable wastes to Horse Point landfill Site.
- Peaks Management Plan completed and endorsed by ENRC on September 2019.
- ❖ 100% completion of agreed endemic plant Propagation Plan.
- Fisheries Licence Policy established and endorsed by ENRC in January 2020.
- Entomology training delivered in February 2020.
- ❖ 3 Best practice guidelines completed and implemented.
- ❖ 85% delivery of 2019 tagging programmes by March 2020

- ❖ Waiting time for routine doctor-led outpatient appointments maintained at less than 10 working days − 100%.
- Business Case developed for a Psychiatric Intensive Care Unit (PICU). Project approved as a micro-project under the Economic Development Investment Programme (EDIP) for delivery in 2020/21.
- ❖ 100% of all school children with consent have annual weight screening completed.
- ❖ St Helena healthcare acquired MRSA bacteremia infections maintained at zero.
- ❖ 100% of planned port health clearance conducted.
- 95% of requested pest control services were delivered within 10 working days.
- ❖ 100% of reported food and water-borne diseases outbreaks investigated.
- ❖ Both service and accreditation maintained. Yearly surveillance for accreditation for 2020 due 27-29 May 2020.
- ❖ 67% of registered diabetics receive annual HbA1c check.
- ❖ 80% of contact points with Feedback forms for service users.
- ❖ 100% of patient complaints received are reviewed and responded to within the agreed timeline.

### **CHILDREN & ADULT SOCIAL CARE**

- Children Social Care threshold document established and this has been shared with stakeholders.
- Respite service established.
- Corporate parenting training and strategy delivered to key stakeholders.

- ❖ All residents of Ebony View, Piccolo Hill and the Community Care Complex have person centered care plans outlining their individual needs.
