- This Table shows the current status of all extant St Helena Ordinances enacted from 1849. It also shows the destination of all Ordinances enacted since 2nd June 1930 when the first Revised Edition was published. Ordinances repealed, disallowed or otherwise dealt with prior to that date are omitted; details can be found in the 1929 Revised Edition of the Laws of St Helena, Ascension and Tristan da Cunha.
- A reference to an Ordinance being 'listed' is to the <u>Alphabetical List</u> of Ordinances or to the List of Ordinances by Category on the <u>Laws of St Helena</u> page. The revised texts of all those Ordinances are in this Revised Edition and there are links in the <u>Alphabetical List</u>.
- A reference to a 'Cap.' is to a Chapter in the 2001 Revised Edition of the Laws.
- Laws are shown as 'Omitted' if they are spent or have had effect or are purely personal, or apply only to Ascension or Tristan da Cunha; see the separate <u>List of Omitted Ordinances</u>.
