

## 3. ADDRESS BY THE PRESIDENT

Please be seated. Honourable Members, ladies and gentlemen, welcome to this tenth meeting of the Legislative Council. May I first congratulate the Honourable Acting Financial Secretary, the Honourable Dax Richards, on his appointment and welcome him to this Honourable Council. I am aware, Honourable Member, that you have already taken the appropriate Oaths of Office.

Honourable Members will, of course, be aware that this tenth meeting of Legislative Council, which is held so very soon after our recent ninth meeting, is called especially to enable this Council to fill the vacancies that currently exist on some of our Council Committees. This is necessary to do so that the work of these Committees may proceed effectively and efficiently. This meeting will therefore focus on electing a Chairman for the Environment and Natural Resources Committee and a member for the Public Accounts Committee. These vacant positions, as Honourable Members will know, are as a result of the resignation of the Honourable Wilson Duncan from the Chair of the Environment and Natural Resources Committee and the resignation of the Honourable Brian Isaac from the membership of the Public Accounts Committee, both of which followed changes in membership of the Executive Council through elections held earlier this month. Honourable Members will, I know, wish me to thank on their behalf the Honourable Wilson Duncan and the Honourable Brian Isaac for the valuable service they have given to their respective Committees in the past

and will, I am sure, join me in wishing them well in the new positions that they hold or may take in the future in helping to strengthen the work of this Council. Thank you, Honourable Members.

As Honourable Members have agreed that this meeting should confine its business to that of the elections, to which I happily concur, no other item, except that of the adjournment debate, to which Honourable Members can speak, has been placed on today's Order Paper. Mr Speaker, thank you, I beg to move that this House do now adjourn sine die.

## The Hon. Lawson Henry -

Mr Speaker, I rise in support of this adjournment debate and would ask the Chief Secretary to update listeners and this House on what is the current position on discussions with regard to access for those St Helenians living on Ascension Island and the Falkland Islands post airport operations in February 2016 and the RMS being taken out of service. I also take this opportunity to again acknowledge the significant financial contribution that those Saints living on these islands have made and still do to our economy here on St Helena over many years by remittances and have been able to invest in building their own homes, thus saving this Government hundreds of thousands of pounds in social housing. As constituents of St Helena with the right to vote, SHG has a responsibility towards these Saints. I would like to remind the House too that it was only by the votes cast by Saints that live on these islands at the time of the referendum that put air access in favour of continued sea access. Mr Speaker, I beg to move and support this adjournment debate.

## The Speaker -

Thank you, Honourable Member. Any other Honourable Member wishes to speak to the adjournment debate? Honourable Corinda Essex?

## The Hon. Dr Corinda Essex -

Mr Speaker, I was not anticipating speaking in the adjournment debate today as it is so quick after the last formal session. However, I have been approached by a number of constituents who have requested me to do so. I was even flagged down in the street a few minutes before entering the Honourable House today. The topic that is causing grave concern is aspects of delivery within the Public Health Sector and this is of an order that justifies it being brought to the attention of this Honourable House. In particular, this relates to the availability of Doctors out of normal working hours, I will be providing details of specific cases to the Honourable Chief Secretary. Thank you, Mr Speaker.

## The Speaker -

Thank you, Honourable Member. Any other Honourable Member wish to speak to the adjournment debate? No other Honourable Member wishes to speak, the Honourable Chief Secretary?

### The Hon. Roy Burke -

Thank you, Mr Speaker. The two issues that have been raised this morning, as far as the Ascension Island link is concerned, members will be aware that this is a matter which is being taken forward by the Ascension Island Government. It is in the process of a commercially confidential tender at the moment, it would be inappropriate to comment further on the current discussions that are going in so far as to say that we should have more news before the end of this month on the direction that that's going.

As far as the issue in respect of the Public Health Department, I look forward to the Honourable Member's discussions or documentation so that we can take that forward and I'll take them up with the Health Directorate.
