Will the Hon Financial Secretary tell this Council whether income from taxes generated from the introduction of air services will have any impact on the level of financial aid the Island receives from the UK Government?

Will the Hon Chairman of the Environment and Natural Resources Committee tell this Council what progress has been made in relation to the review of land leases and rents?

Will the Hon Financial Secretary tell this Council what are the risks to the sustainable development of St Helena resulting from the prolonged delay in approval of funding for a capital programme beyond the current month?

Will the Hon Acting Chief Secretary tell this Council what measures have been taken to properly catalogue and preserve the valuable material following the closing down of Radio St Helena?
