AN ORDINANCE to regulate the use of recreation and playgrounds.

Short title

1. This Ordinance may be cited as the Public Recreation Grounds Ordinance,

Interpretation

2. In this Ordinance, and in any regulations made under it, unless the context otherwise requires—

"child" means a person who is under the age of 10 years;

"young person" means a person who is 10 years of age or over and under the age of 16 years.

Reservation of lands

3. The Governor may declare any Crown land to be a public recreation ground and reserve the use of any portion of such land so declared to be a children's or young persons' playground.

Powers of the Governor in Council

- **4.** The Governor in Council may make regulations providing for—
- (a) the uses to which public recreation grounds may be put;
- (b) the times of day that they are to be open to the public;
- (c) the closing of any public recreation ground;
- (d) the general management and control of public recreation grounds and for all other matters connected with them.

Offences

- 5. It is an offence for a person to—
- (a) wilfully damage any public recreation ground or any article of equipment on a public recreation ground;
- (b) obstruct persons lawfully using a public recreation ground;
- (c) use a public recreation ground contrary to the regulations;
- (d) use a public recreation ground when it is closed.

Penalty: A fine of £100.

PUBLIC RECREATION GROUND ORDERS

(Section 3)

The following places have been declared as public recreation grounds reserved for the use of children or young people—

- (a) the upper half of the Lower Graveyard
- (b) Francis Plain

PUBLIC RECREATION GROUNDS (CLOSING) REGULATIONS, 1954

(Section 4)

Citation

1. These Regulations may be cited as the Public Recreation Grounds (Closing) Regulation, 1954.

Temporary closing for purposes of public interest or welfare

2. On application by any organisation, group of persons or individual member of the public, the Council Committee may, in their discretion, order the temporary closing to the public of the whole or any part of any public recreation ground or playground to enable such public recreation ground or playground to be used for a specific purpose on a day or days to be specified, if such purpose is, in the opinion of the Council Committee, one of public interest or welfare.

Temporary closing for purposes of management, maintenance or development

3. The Council Committee may, in their discretion, order the temporary closing to the public of the whole or any part of any public recreation ground or playground for the purposes of management, maintenance or development for a period or periods that the Committee considers necessary.

PUBLIC RECREATION GROUNDS (MANAGEMENT AND CONTROL) REGULATIONS, 1999

(Section 4)

Citation

1. These Regulations may be cited as the Public Recreation Grounds (Management and Control) Regulations, 1999.

Management and control of recreation and playgrounds

- **2.** (1) A Council Committee ("the Committee") is to be responsible for the general management and control of public recreation grounds and playgrounds.
- (2) The Committee may, in respect of the Public Recreation Ground known as Francis Plain, delegate the day to day responsibility for management and control to a public officer employed within the Education Department.

Committee to determine certain matters

- **3.** The Committee may prescribe—
- (a) rules and procedures for the use of Francis Plain; and
- (b) fees payable for the use of Francis Plain.
