#### **CORRECTION ORDER**

(Section 11)

IN EXERCISE of the powers conferred by section 11 of the Revised Edition of the Laws Ordinance, 1999, I hereby rectify the following clerical, printing or other errors in the Revised Edition:

#### STHELENA:

#### **Dentists Ordinance**, 1955

In section 4 delete "Chief Medical Officer" and substitute "Senior Medical Officer".

#### **Domestic Abuse Ordinance**, 2017

In section 8A(5) insert the word "section" before 8(1)(c).

### Food Safety Ordinance, 2016

In the Index reference to Food Safety (General Food Hygiene) Regulations delete the reference to "Legal Notice 5 of 2017" and substitute "Legal Notice 6 of 2017".

#### **Interpretation Ordinance, 1968**

In section 22(1) delete the reference to "subsection (1A)" and substitute "subsection (2)". In section 22(2) delete the reference to "subsection (1A)" and substitute "subsection (1)".

## Road Traffic Ordinance, 1985

Delete section 1, other than the heading, and substitute the following:

"1. This Ordinance may be cited as the Road Traffic Ordinance, 1985 and comes into force on 1st October, 1985.".

#### **Telecommunications Ordinance, 1989**

In the Wireless Telegraphy Regulations, 1989 delete the reference to "Sections 7 and 54" below the heading and substitute "Sections 7, 53 and 54".

# **Customs Ordinance, 2001**

In section 1 delete "2002" and substitute "2001".
