Instrument, appointing LOUISE JOANNE MACMORRAN, to be Governor's Deputy.

WHEREAS it is provided inter alia, in section 28 of the Constitution set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009 that whenever the Governor has occasion to be absent from the seat of government for a period that he or she has reason to believe will be of short duration, the Governor may, by Instrument under the public seal, appoint any person in St Helena to be his or her Deputy during such absence and in that capacity to discharge on the Governor's behalf during such absence such of the functions of the office of Governor as may be specified in that Instrument:

AND WHEREAS I shall be on annual leave from 3 - 7 July 2018.

NOW THEREFORE, I Lisa Honan, Governor of St Helena hereby appoint Louise Joanne MacMorran, Head of Governor's Office to be my Deputy during the period of my absence from 3 - 7 July 2018, and in that capacity to discharge on my behalf all such powers and authorities vested in the Governor (save the power of pardon) as, but no more than, she may from time to time deem to be necessary for the peace, order and good government of St Helena, Ascension and Tristan da Cunha and the well being of their people.

And I charge the said Louise Joanne MacMorran that she shall, during my aforesaid absence, conform to and observe all such instructions as I may from time to time address to her for her guidance.
