2. The Hon Dr Corinda Essex to ask the Hon Chief Secretary:

Will the Hon Chief Secretary tell this Council what is the current situation regarding the independent review of Connect Saint Helena Ltd that was requested in a Motion passed unanimously in this House almost a year ago?

3. The Hon Dr Corinda Essex to ask the Hon Chairman of the Health Committee:

Will the Hon Chairman of the Health Committee tell this House what arrangements are in place to ensure that persons who require medical clearance at short notice for reasons such as employment or travel insurance can obtain this within the necessary timeframe? 4. The Hon Cyril Leo to ask the Hon Financial Secretary:

Will the Hon Financial Secretary tell this House what progress has been made by DFID and SHG in respect of a Capital Programme for St Helena?

5. The Hon Brian Isaac to ask the Hon Chief Secretary:

Will the Hon Chief Secretary inform this House what procedures are in place for the upkeep of Amenity Areas around the Island and related facilities in respect of Health and Safety?

6. The Hon Christine Scipio to ask the Hon Attorney General:

Will the Hon Attorney General say what Laws are available to protect the public from sexual or other harassment when using various taxi services systems, and will she say whether or not our current law restricts registered offenders from operating as taxi drivers?

7. The Hon Corinda Essex to ask the Hon Financial Secretary:

Will the Hon Financial Secretary tell this House what are the key milestones and expected time line for reaching the next agreed aid settlement with the Department for International Development?

8. The Hon Christine Scipio to ask the Hon Chairman of the Environment and Natural Resources Committee:

Will the Hon Chairman of the Environment and Natural Resources Committee say if his Committee will consider regulating the very high fares that are being charged by some taxi operators, so that there can be some consistency in the fees being charged by all such operators?

Will the Hon Chief Secretary say what action has the St Helena Government undertaken to progress St Helena's position on the United Kingdom's Tentative List of potential World Heritage Sites inscribed by the United Nations Educational, Scientific and Cultural Organisation, (UNESCO)? 10. Will the Hon Financial Secretary tell this House what are the criteria and processes for appointments to the Boards of SHG state owned entities?
