FORESTRY ORDINANCE, 1954

VARIATION OF NATIONAL FORESTS

- 1. Notice is hereby given under section 12 of the Forestry Ordinance, 1954, that the Governor in Council is proposing to vary the Statutory Rules and Orders constituting the National Forests as set out in the Schedule, so that land as described in the Schedule may be excised from the relevant National Forests and be made available to the Crown Estates Officer to be used for other purposes.
- 2. Any person having any objections to the proposed variation of these Constitution Orders or wishing to make any representations in connection therewith, should submit such objection or representation, in writing, to the Chief Secretary, The Castle, Jamestown on or before 14 May 2019.
- 3. According to this proposal, the variation of the Statutory Rules and Orders will not come into force before **25 June 2019**.
