Threshold for the Adult Support Team

<u>What we do:</u> The Adult Support Team is passionate about making a difference and helping <u>vulnerable people</u> to live their best life. We demonstrate care and respect equality of opportunity. We listen to those that we work with in order to promote their wellbeing in a holistic way.

<u>Vulnerable Person:</u> Someone aged 18 or over who is or may be in need of community care services, by reason of mental or physical disability, frailty or illness, in order to achieve their best life; AND who, does not have the ability to fully meet the needs of their everyday care without support; AND who, is or may be unable to protect themselves against significant harm or exploitation.

<u>What we don't do:</u> We are not responsible for welfare benefits, we do not deal with housing, we are not a health service provider, we do not provide legal advice and we are not a transport provider.

Everybody referred to the Adult Support Team will have an assessment of their needs; the outcome of which determines the support and ongoing involvement offered.

There is no hierarchy to these types of need – all are equally important.

In order to meet the threshold for ongoing Adult Support Team involvement the adult's vulnerability must impact on at least one of the areas of need in a significant way or the cumulative effect of the impact on a number of the areas of need means that they have a significant impact on the adult's overall wellbeing.
