
St Helena Island is a British Overseas Territory situated in the South Atlantic Ocean, at 15° 56′ south and 5° 45′ west with a population of 4,425 (June 2019)

WEATHER & CLIMATE

For most of the year, temperatures range between
70-80°F (20-27°C) but nights and early mornings can
get cooler in the months of June, July and August.
Rains usually begin from March to May and again from
July through to September, with April and August the
wettiest months.



THE PEOPLE

St Helenians, known as "Saints", are mainly descended from Europeans, Chinese labourers, slaves from Madagascar, Asia and Africa and prisoners of war. The most notable prisoners to have lived in St Helena are the French Emperor Napoleon Bonaparte, Zulu King Chief Dinizulu and the Boer prisoners of war.

This history of diverse cultures has shaped and developed the foundations of who the Saints are today. Saints are recognised for their hospitable nature and friendliness – everyone waves and greets each other, even passing cars.

The language spoken on St Helena is English, but the Saints also have their own unique dialect.

ST HELENA CURRENCY

The currency on St. Helena and Ascension Island is the Saint Helena Pound (SHP), which is equivalent to the British Pound (GBP). The SHP and GBP Sterling are accepted on both islands, but SHP is not accepted outside of St Helena and Ascension Island.



OPPORTUNITIES AND GROWTH INDUSTRIES


There are a range of sectors with growth potential in import substitution and export opportunities. Connecting to the fibre optic subsea cable during 2021 will further enhance opportunity.

With an appetite for local and external organisations to mutually benefit from increased capacity; networking and new partnerships, the landscape for development and growth opportunities is exciting.









INVESTMENT AND TAX INCENTIVES

ACADEMIA, RESEARCH AND CONFERENCES





St Helena is poised to offer a variety of opportunities to the international research and academic community. The commercial air service allows the island to host academic conferences conveniently, enhance global academic links. St Helena invites researchers, archaeologists and conservationists to work in partnership with us.

Extensive potential for research in social technological, economical, environmental and political themes, exists in parallel to unique biodiveoristy, natural capital and history.

The St Helena Research Institute (SHRI) is a new organisation based on the island. The institute is affiliated to the St Helena Lifelong Learning Centre, dedicated to supporting basic, applied and experimental research development in St Helena. Predicated on ethical and responsible research that respects and protects the people, heritage and environment, foundations have been laid for purposeful, meaningful and equitable development opportunity.

AGRICULTURE



Agriculture remains an area of significant growth, over £4m worth of food was imported in 2018/19. With plans for both increased population and visitor numbers, there are major opportunities within this sector to reduce the trade deficit and improve food security.

St Helena Coffee is a rare strain of the original Green Tipped Bourbon Arabica coffee introduced in 1733. It is currently produced in small quantities for export and local consumption. Over £100,000 of St Helena Coffee was exported in 2018/19, and retailed at Harrod's at a premium. The opportunity exists to grow more and roast more, for both local and domestic markets.

Claimed as disease free, the production of St Helena Honey and Queen Bees for export is another opportunity for further potential investment.

"There are several excellent opportunities for the development of agri-business on St Helena. The production of field vegetables, salad crops and fruit could be significantly scaled-up to supply the on-island market demand. Opportunities also exist for the export of produce, including an expansion of coffee and honey production, and potentially vegetables to Ascension Island. St Helena has a sub-tropical climate, good soils and a strong infrastructure. An investment in appropriate technology, supply chain management and market development would pay dividends"

As the historic cornerstone of the St Helenian community, fishing has been and always will be a fundamental part of the island's culture. The fishery has provided sanctuary and security for generations and is an important source of income and employment.

Further opportunities exist for both new and resident operators.

The St Helena Fisheries Co-operation (SHFC) provides an on island fish processing facility where there is an opportunity for an investor to take over this function or re-develop it accordingly.

ADDITIONAL OPPORTUNITIES



Bottled Water

During 2018/19 over, £85,000 was spent importing bottled water to St Helena. Each plastic bottle contributes to the plastic waste which is landfilled on St Helena every year.

Underground fresh water stores are already utilised, presenting an opportunity for the provision of treated and bottled water on Island, coupled with a bottle deposit scheme.

Ship Registry and Sailing Qualifications

St Helena experiences over 600 visitors a year arriving on yachts, especially during the World Arc Rally in January. St Helena is able to offer ship registry services and provide sailing courses, while capitalising on existing interest

St Helena is a member of the prestigious Red Ensign Group allowing registration of vessels up to 150 gross tons, with an extension to 400 gross tons for pleasure vessels.

Liquor, Wines and Beers

St Helena proudly boasts having one of the most remote distilleries in the world, offering local products such as Midnight Mist (Coffee liquor) and Tungi (prickly pear liquor) and Jamestown Gin (Juniper Berry spirit) with locally sourced and grown ingredients.

Other offerings include brandy, White Lion Rum and wines. There is potential to develop viticulture on island due to the favourable climate and landscape.

Traditional Products

St Helena is home to a variety of creative arts and crafts, including jewellery making, photography and carpentry, with traditional craft-works such as flax work and lace making forming part of its unique history and heritage.

There are also crafts produced using local and recyclable materials and these crafts can be found in the Arts and Crafts shop.



MARINE ENVIRONMENT



With St Helena's pristine sub tropical waters, underwater structures and an abundance of marine life (some found nowhere else on earth) St Helena's marine environment is a major natural asset.

Conditions allow seasoned travellers, explorers, scientists, researchers and novices, the opportunity to meet on and below the surface of this adventurer's playground.

- Clear and warm sub-tropic waters with 15 - 25m visibility and temperatures of 19 - 25°C
- 18th Century wrecks with thrilling scuba diving and snorkelling

- Whales, whale sharks, dolphins, rays

RAW ENVIRONMENT



...EXTRAORDINARY ENVIRONMENT

The Island's unspoiled landscape of lush green, cloud covered central peaks and breath-taking rugged coastline provide an exceptionally diverse range of habitats, and features of geological interest

St Helena is on the tentative list as a future UNESCO World Heritage Site. The landscape reflects areas coated in naked rock and coloured paint pallet deserts, with higher interiors of tropical green foliage. The landscape is one of our natural assets that will excite scientists, researchers, conservationists, and preservationists.

- The island is a result of an extinct volcano that emerged from the ocean 12 – 14 million years ago
- There is a diverse range of endemic fauna and flora
- Of the 1,547 (94%) endemic species found within the Overseas Territories, over 500 are found on St Helena
- There is spectacular scenery with Diana's Peak rising 823m above sea level
- The Diana's Peak National Park is home to many of the island's endemic plant species



HISTORY AND HERITAGE



St Helena promotes a fascinating history that touches many aspects of the world gone by. A British island initially governed by the East India Company, and later the Crown. It was a strategic port of call under the British Empire until the opening of the Suez Canal and the advent of the Steam Ship.

St Helena's heritage has a significant legacy of converging and emerging culture, and spans eras of monumental change. St Helena was a strategically-fortified island. Historic buildings, especially in the capital Jamestown, boast a distinct Georgian flavour featuring outposts with majestic views where you can reflect the change of rule and attempted coups.

- Discovered by the Portuguese in 1502 controlled by the Dutch and later by the British
- Famous prisoners Napoleon Bonaparte, Chief Dinizulu, Boers
- In 1840 became home to the British West African Squadron which worked to suppress the slave trade
- St Helena island was pivotal in the abolition of slavery as the location for many slaver trials
- Visiting astronomers Sir Edmund Halley and Neville Maskelyne
- Captain Cook explorer
- Charles Darwin naturalist, geologist and biologist
- Oldest known land vertebrate Jonathan the Giant (Seychelles) Tortoise estimated to be over 187 years old
