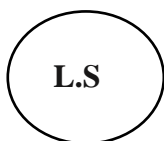

Instrument, appointing Mr Allen Thomas Cansick to be Attorney General

**WHEREAS** it is provided, inter alia, in section 46(1) of the Constitution set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009, that there shall be an Attorney General of St Helena who shall be the principal legal adviser to the Government of St Helena.

**AND WHEREAS** it is provided for in section 46(2) and (3)(b) thereof that the Attorney General shall be an officer of the St Helena Public Service appointed by the Governor, acting in his or her discretion and with the approval of a Secretary of State, for a term specified in the instrument of appointment.

**NOW THEREFORE**, in exercise of the powers vested in me by section 46(2) and (3) of the Constitution, and acting in my discretion and with approval of the Secretary of State, I hereby appoint Mr Allen Thomas Cansick to be Attorney General of St Helena for a term of two years with effect from 5 November 2019.

By virtue of sections 150 and 215 of the Constitution, the Attorney General of St Helena also serves as the Attorney General of Ascension and Tristan da Cunha.
