## TRADE MARKS (REGISTRATION) ORDINANCE, 1949

*TRADE MARKS (REGISTRATION)(AMENDMENT) RULES, 2020*

In exercise of the powers conferred by section 13 of the Trade Marks (Registration) Ordinance, 1949, the Governor in Council makes the following Rules:

**Citation and commencement**

1. These Rules may be cited as the Trade Marks (Registration)(Amendment) Rules, 2020, and come into force on publication.

**Fees**

2. The First Schedule to the Trade Marks (Registration) Rules, 1949, is amended by revoking the table of fees and substituting the following:



6. For a certificate of registration of a registered user of a trade mark	£53.65
7. For filing notification of renewal of a trade mark or a series of trade marks, including the endorsement on the certificate of registration	£69.75
8. On an application under section 16 of the Ordinance:	
For cancellation of the registration of a mark wholly	£40.80
For cancellation of the registration of a mark in part	£30.05
For correction of any clerical error	£30.05
For change of name and/or address	£30.05
9. For certified copies or extracts of any documents filed:	
(a) if copies are photographic, per sheet	£3.25
(b) If copies are type-written, per folio of 100 words	£3.25
(c) In either case, minimum fee	£40.80
10. For every search of the Register	£16.10".
