REVIEW OF FEES AND CHARGES

Committee is asked to agree the proposed increases in fees and charges as set out in the table below and in the attached draft Legal Notices for statutory fees.

Background and Considerations

- 1. As part of the 2021-2024 budget process, Directorates have been asked to review statutory and discretionary fees and charges in accordance with SHG's Charging Policy 2013.
- 2. Statutory fees falling under the remit of the Finance Committee are those for Companies, Trade Marks and Patents fees. Companies and Trade Marks fees were last increased with effect from April 2020. Patent Fees have remained the same since 1989. Responsibility for increasing these fees has been that of the Registrar of Patents but a Correction Order was issued in 2018 transferring the responsibility to issue Regulations to the Governor in Council; this was overlooked during the review of fees and charges earlier this year.
- The table below shows current fees and proposed fees which the Finance Committee is asked to consider and agree for implementation from 1 April 2021; inflation of 2.6% has been applied, as required in the MTEF 2021-24 guidelines.
