**CONSTITUTION OF ST HELENA, ASCENSION AND TRISTAN DA CUNHA****APPOINTMENT OF ACTING JUDGE**

**WHEREAS** Part 6 of the Schedule to the St Helena, Ascension and Tristan da Cunha (Constitution) Order, 2009 establishes a Supreme Court for St Helena, and section 84(1) thereof provides for the appointment of a Chief Justice and such number of other judges of the said Court as may be prescribed by law.

**AND WHEREAS** it is provided by section 90(2) thereof that the Governor may, acting in accordance with the recommendation of the Chief Justice, appoint such acting judge of the Supreme Court.

**AND WHEREAS** the Chief Justice Charles Ekins Esq has recommended the appointment of Judge Patrick Thomas as acting Judge of the Supreme Court of St Helena during the time the Chief Justice is unable to perform the functions of that office.
