PUBLIC HEALTH ORDINANCE, 1939

PUBLIC HEALTH (PREVENTION OF FORMIDABLE DISEASES) (CORONAVIRUS NO. 2) REGULATIONS, 2020

EXEMPTION FROM ISOLATION

By virtue of the power vested by regulation 4(6) of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020, the Governor in Council by Order exempts the naval crew members of the HMS Protectorate, who are expected to arrive by air in St Helena on or around 7 September 2021, from the requirement to remain in isolation for the full period of isolation as required by regulation 4(1). The crew members will be arriving in St Helena for purposes of effecting a crew change of the naval vessel which will be arriving in the Jamestown port on or around 6 September 2021.

This exemption is granted subject to the condition that the naval crew members must at all times comply with the requirements and remain in isolation as directed by a Proper Officer until their departure from St Helena on the HMS Protectorate.

This exemption does not otherwise affect the application of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020.

NO. 2) REGULATIONS, 2020****EXEMPTION FROM ISOLATION**

By virtue of the power vested by regulation 4(6) of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020, the Governor in Council by Order exempts Adrian Greaves, an engineer, who is expected to arrive in St Helena on or around 7 September 2021 to service and repair the security equipment at the St Helena Airport, from the requirement to remain in isolation for such period or periods as required by him to perform these functions.

This exemption is granted subject to the condition that this person must at all times comply with the requirements set by a Proper Officer and must return to and remain in isolation as soon as these functions have been completed until his departure from St Helena.

This exemption does not otherwise affect the application of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020.

NO. 2) REGULATIONS, 2020****EXEMPTION FROM ISOLATION**

By virtue of the power vested by regulation 4(6) of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020, the Governor in Council by Order exempts the following persons, who are expected to arrive in St Helena on or around 7 September 2021 to carry out essential training and to assess and perform essential maintenance on the fuel facilities at St Helena Airport, from the requirement to remain in isolation for such period or periods as required by them to perform these functions:

This exemption is granted subject to the condition that these persons must at all times comply with the requirements set by a Proper Officer and must return to and remain in isolation as soon as these functions have been completed until the earlier of their departure from St Helena or the completion of the required period of isolation under the Regulations.

This exemption does not otherwise affect the application of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020.
