CONSTITUTION OF ST HELENA, ASCENSION AND TRISTAN DA CUNHA APPOINTMENT OF ACTING JUDGE

WHEREAS Part 6 of the Schedule to the St Helena, Ascension and Tristan da Cunha (Constitution) Order, 2009 establishes a Supreme Court for St Helena, and section 84(1) thereof provides for the appointment of a Chief Justice and such number of other judges of the said Court as may be prescribed by law.

AND WHEREAS it is provided by section 90(2) thereof that the Governor may, acting in accordance with the recommendation of the Chief Justice, appoint such acting judge of the Supreme Court.

AND WHEREAS the Chief Justice Charles Ekins QC has recommended the appointment of Judge Carmel Wall as acting Judge of the Supreme Court of St Helena for all matters incidental to the case of Moyce v Attorney General on St Helena.

NOW THEREFORE, in exercise of the powers vested in me and acting in accordance with section 90(2) with the recommendation of the Chief Justice, I hereby appoint Judge Carmel Wall to act as a Judge of the Supreme Court for the above named case.

CONSTITUTION OF ST HELENA, ASCENSION AND TRISTAN DA CUNHA

Power to Dispose of Land
