### OMITTED LAWS

The texts of the following categories of laws or provisions have been omitted by virtue of section 6(a) of the Revised Edition of the Laws Ordinance, 1999:

- Ordinances or parts of Ordinances which have been expressly and specifically repealed or which have expired or have become spent or have had their effect;
- Repealing enactments contained in Ordinances and also all tables and lists of repealed enactments, whether contained in Schedules or otherwise;
- Preambles to Ordinances which can, in the opinion of the Commissioner, conveniently be omitted;
- Enactments prescribing the date when any Ordinance or part thereof is to come into operation, if in the opinion of the Commissioner such enactments can conveniently be omitted;
- Amending Ordinances, or parts of such Ordinances, if the amendments made by them have been embodied by the Commissioner in the Ordinance to which they relate;
- Enacting clauses.
