PUBLIC HEALTH (PREVENTION OF FORMIDABLE DISEASES) (CORONAVIRUS NO. 2) REGULATIONS, 2020

EXEMPTION FROM ISOLATION

By virtue of the power vested by regulation 4(6) of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020, the Governor in Council by Order exempts Shaun Leak, an engineer, who is expected to arrive on or around 07 March 2022 for the purposes of carrying out critical engineering work at the Oxygen Generating Plant at Bradley's Camp, the St Helena Government (SHG) Main Data Centre at Carnarvon Court and Connect St Helena at Carnarvon Court from the requirement for isolation under regulation 4(1) for such period as is required by him to carry out his work.

This exemption is granted subject to the condition that he must at all times comply with the requirements and remain in isolation as directed by a Proper Officer until his departure from St Helena.

This exemption does not otherwise affect the application of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020.

EXEMPTION FROM ISOLATION

By virtue of the power vested by regulation 4(6) of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020, the Governor in Council by Order exempts Rajaratnam Jajeesan, an engineer, who is expected to arrive on or around 07 March 2022 for the purposes of carrying out critical engineering work at the Oxygen Generating Plant at Bradley's Camp, the St Helena Government (SHG) Main Data Centre at Carnarvon Court and Connect St Helena at Carnarvon Court from the requirement for isolation under regulation 4(1) for such period as is required by him to carry out his work.

This exemption is granted subject to the condition that he must at all times comply with the requirements and remain in isolation as directed by a Proper Officer until his departure from St Helena.

This exemption does not otherwise affect the application of the Public Health (Prevention of Formidable Diseases) (Coronavirus No. 2) Regulations, 2020.
