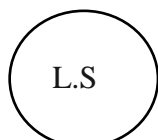

WHEREAS it is provided in section 28 of the Constitution, set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009, that whenever the Governor has occasion to be absent from the seat of government for a period that he or she has reason to believe will be of short duration, the Governor may, by Instrument under the public seal, appoint any person in St Helena to be his or her Deputy during such absence and in that capacity to discharge on the Governor's behalf during such absence such of the functions of the office of Governor as may be specified in that Instrument.

CONSTITUTION OF ST HELENA, ASCENSION AND TRISTAN DA CUNHA**APPOINTMENT OF ACTING JUDGE**

WHEREAS Part 6 of the Schedule to the St Helena, Ascension and Tristan da Cunha (Constitution) Order, 2009 establishes a Supreme Court for St Helena, and section 84(1) thereof provides for the appointment of a Chief Justice and such number of other judges of the said Court as may be prescribed by law.

AND WHEREAS section 84(3)(b) thereof provides that if the state of the business of the Supreme Court makes it desirable that an additional person should be appointed by whom the Supreme Court may be held, the Governor, acting in his or her discretion, may decide that an acting judge should be appointed to hold the Supreme Court.

AND WHEREAS section 90(2) thereof provides that the Governor, acting in accordance with the recommendation of the Chief Justice, shall appoint any such acting judge of the Supreme Court.

AND WHEREAS the Chief Justice Rupert Trevelyan Jones has recommended the appointment of Charles Ekins QC as acting Judge of the Supreme Court of St Helena for all matters incidental to the case of AB, AC and NK v Attorney General of St Helena.

NOW THEREFORE, in exercise of the powers vested in me by sections 84(3)(b) and 90(2) and acting in accordance with the recommendation of the Chief Justice, I hereby appoint Charles Ekins QC to act as a Judge of the Supreme Court for the above named case.
