NOW THEREFORE, in exercise of the powers vested in me by section 37F(6) of the Constitution, I hereby appoint the Honourable Ms Christine Lilian Scipio to be my Deputy with effect from 11 September 2022 until the date of my return to St Helena, and, in that capacity, to discharge on my behalf during that period all the functions of the office of Chief Minister, including the functions relating to the portfolios which are the responsibility of the Chief Minister.
