

LOCALITY & ZONING

The proposed development is situated opposite the junction to Kunjie Field at Scotland, where the site is designated on the edge of the Green Heartland with no conservation area restrictions.


Diagram 1: Location Plan



PROPOSED

The proposal is to relocate the existing bus shelter from the Scotland roundabout, to a new location south of the roundabout on the road to White Gate. The bus shelter to be removed is a timber cladded structure with mono-pitched and measures approximately 5m². To relocate the shelter, works needed at the new location will consist of removing the existing road verge and creating a level platform that will be supported by a gabion basket.

Diagram 2: Site Plan






Diagram 3: Bus Shelter to be relocated

OFFICER'S ASSESSMENT

The rationale for the relocation is to eliminate a highway concern of buses stopping just before the junction on the Scotland roundabout. This can be avoided by relocating the bus shelter at a more suitable location that will alleviate the concern altogether. The siting of the shelter at the proposed location is considered more appropriate, where the structure itself is not the typical 'malta' design that is usually proposed, but as the area is forested, the re-purposing of the existing bus shelter is appropriate. Overall, the impact of the proposal will be minimal on the landscape, and therefore can be supported.
