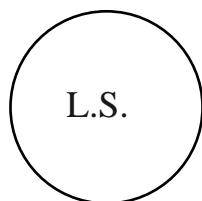

Instrument, appointing Deputy Chief Minister

**WHEREAS** it is provided in section 37 of the Constitution, set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009, that there shall be a Chief Minister of St Helena;

**AND WHEREAS** it is provided in section 37F(6) thereof that whenever the Chief Minister is absent from St Helena or otherwise unable to discharge the functions of the office for a period that he or she has reason to believe will be of short duration, the Chief Minister may appoint, by instrument, any other Minister as his or her Deputy for the duration of such period to discharge the functions of the office of Chief Minister as specified in that instrument.

**AND WHEREAS** I will be absent from St Helena for official business with effect from 22 October 2022 and anticipate returning on 12 November 2022.

**NOW THEREFORE**, in exercise of the powers vested in me by section 37F(6) of the Constitution, I hereby appoint the Honourable Ms Christine Lilian Scipio to be my Deputy with effect from 22 October 2022 until the date of my return to St Helena, and, in that capacity, to discharge on my behalf during that period all the functions of the office of Chief Minister, including the functions relating to the portfolios which are the responsibility of the Chief Minister.
