

WHEREAS it is provided in section 28 of the Constitution, set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009, that whenever the Governor has occasion to visit Ascension or Tristan da Cunha, the Governor may, by Instrument under the public seal, appoint any person in St Helena to be his or her Deputy during such absence and in that capacity to discharge on the Governor's behalf during such absence such of the functions of the office of Governor as may be specified in that Instrument.

**AND WHEREAS** I will be absent from St Helena for official business on Ascension Island from 21 January 2023 until my departure from Ascension to the United Kingdom.

**NOW THEREFORE**, I Nigel James Phillips CBE, Governor of St Helena, hereby appoint Gregory Charles Roland Gibson, Head of Governor's Office to be my Deputy during the period of my absence from 21 January 2023 until my departure from Ascension to the United Kingdom, inclusive, and in that capacity to discharge on my behalf all such powers and authorities vested in the Governor (save the power of pardon) as, but no more than, he may from time to time deem to be necessary for the peace, order and good government of St Helena and Tristan da Cunha and the well being of their people.

And I charge the said Gregory Charles Roland Gibson that he shall, during my aforesaid absence, conform to and observe all such instructions as I may from time to time address to him for his guidance.
