Instrument, appointing Minister, Safety, Security and Home Affairs Portfolio

WHEREAS it is provided in section 37H (1) (a) of the Constitution, that whenever a Minister other than the Chief Minister is absent from St Helena or otherwise temporarily unable to discharge the functions of his or her office, the Governor, acting in accordance with the advice of the Chief Minister, may, by instrument under the public seal –

(a) assign responsibility for the performance of that Minister's functions to another Minister, including the Chief Minister;

NOW THEREFORE, in exercise of the powers vested in the Governor by section 37H(1)(a) of the Constitution, I hereby assign the responsibility for the performance of the Safety, Security and Home Affairs Portfolio to Minister, Martin Dave Henry with effect from 3 March 2023 until Minister, Jeffrey Robert Ellick is able to discharge the functions of his office.



Instrument, appointing GREGORY CHARLES ROLAND GIBSON, to be Governor's Deputy.

WHEREAS it is provided in section 28 of the Constitution, set out in the Schedule to the St Helena, Ascension and Tristan da Cunha Constitution Order 2009, that whenever the Governor has occasion to visit Ascension or Tristan da Cunha, the Governor may, by Instrument under the public seal, appoint any person in St Helena to be his or her Deputy during such absence and in that capacity to discharge on the Governor's behalf during such absence such of the functions of the office of Governor as may be specified in that Instrument.

AND WHEREAS I will be absent from St Helena for official business on Tristan da Cunha.
