ST HELENA, ASCENSION AND TRISTAN DA CUNHA

NOTICE BY HIS EXCELLENCY THE GOVERNOR PURSUANT TO ARTICLE 5 TO THE AIR NAVIGATION (OVERSEAS TERRITORIES) ORDER 2013 (AS AMENDED)

His Excellency the Governor, in exercise of the powers conferred by article 5(1), (3) and (4) to the Air Navigation (Overseas Territories) Order 2013 (as amended) (UK SI 2013 No. 2870) ("the Order"), **Hereby Gives Notice** of the adoption of the following amended Aviation Security Overseas Territories Aviation Requirements ("OTARs").

1. Commencement

The amended Requirements, (cited as OTAR Part 178, Aviation and Cyber Security for Airports and Aircraft Operators, OTAR Part 179, Aviation Security Training and Certification, and OTAR Part 180, Aviation and Cyber Security for Regulated Agents, ("the OTARS"), shall come into force in the Territories of St Helena, Ascension and Tristan da Cunha with effect from the date of the publication of this Notice in the Government Gazette of each of the respective Territories.

2. Applicability and purpose

These Requirements are hereby applied to the Territories of St Helena, Ascension and Tristan da Cunha. Amendments to the Titles and contents of the OTARs are in implementation of International Civil Aviation Organisation ("ICAO") Standards relating to Aviation Security and Cyber Security in respect of airport and aircraft

operations conducted in those Territories, and to replace any such Aviation Security Notices which may have previously been Gazetted.

3. Publication and Access

(1) Article 5(1)(a) provides that the Governor must publish or cause to be published requirements which the Governor considers relevant to the Governor's determination of certain matters before granting a certificate, licence, or other document issued under the provisions of the Order; save that, pursuant to article 5(3) of the Order, when to publish in relation to aviation security would be, or likely to be, detrimental to national security.

(2) Therefore in accordance with article 5(3) and (4) of the Order, I hereby determine that access to the documents specified in this Notice (together with the relevant Overseas Territories Aviation Circulars OTAC 178-1, 179-1, 180-1) may only be provided to any person who, in the opinion of Air Safety Support International Ltd ("ASSI"), has need of that document in order to secure compliance by that person with its provisions and, in such cases, for ASSI to make that document available in such a manner and in such form as ASSI sees fit, consistent with securing compliance with that document.

4. Revocation

Any Notices in any of the above Territories relating to Aviation Security published heretofore pursuant to article 5 are hereby revoked.
