### POST OFFICE (RATES OF POSTAGE) ORDER, 2024

(Section 3)

In exercise of the powers conferred by section 3 of the Post Office (Tristan da Cunha) Ordinance, 1898, the Governor makes the following Order:

# Citation, commencement and interpretation

1. (1) This Order may be cited as the Post Office (Rates of Postage) Order, 2024.
